Item No. 1 Confirmation of the Minutes of the 13th All India Meet of State Legal Services Authorities held at Ranchi on 21st– 22nd March, 2015.

Item No. 2 Appointment of Full Time Secretaries, other officers/supporting staff etc. in each District Legal Services Authority.

- **Action taken for sanction of posts/appointment of full time secretaries in each DLSAs.**

- Posts for Full Time Secretaries have been created in all the 24 Districts of Jharkhand. At the initiative of Hon'ble High Court of Jharkhand and Jharkhand State legal Services Authority, the Govt of Jharkhand has long ago sanctioned the posts of Full Time Secretary, DLSA. However, due to increase in the court matters and shortage of Judicial Officers, the DLSA Secretaries are discharging judicial work during the first half and DLSA work exclusively in the another half. A request has been made to Hon'ble High Court of Jharkhand for issuing necessary directions towards empowering the Secretaries of the DLSAs to work as Full Time Secretaries atleast in a few districts where work load is substantive.

- **Requirement of officers, administerial and supporting staff.**

- The DLSA is manned by Civil Judge (Sr. Div.) as Secretary with the Principal District Judge as its Chairman. At present the supporting staffs of DLSA are placed on deputation from the concerned Civil Court. The State Legal Services Authority, Jharkhand has recently got its Staff Rule framed and the process of appointing permanent staff for the DLSAs is under process.

Suggestion of JHALSA

- **Request may come from Patron-in-Chief/Executive Chairman, NALSA to all the Chief Justices for appointment of Full Time Secretary in the DLSAs where work load is substantive.**
- **Till the staffs are appointed in the DLSA, the staffs may be appointed on contract basis.**

Item No.3 Enhancing quality of Legal Representation.

• Whether the monitoring committees are regularly assessing the progress of cases assigned to Panel Lawyers?

Yes. As per Regulation 10 of Free and Competent Legal Services Regulation 2010 of NALSA, Monitoring Committees have been constituted at the District Level to keep a watch on the progress of legal aided cases.

• What is the frequency and mode of reporting by Panel Lawyers?

➤ The frequency and mode of reporting by panel lawyers is regulated under Regulation 12 of NALSA (Free and Competent Legal Services) Regulation 2010, as per which monitoring committee is required to submit monthly reports once in two months.

• Whether any online Case Tracking System has been developed?

➤ Online Legal Services Tracking System is under advance stage of development in the state of Jharkhand.

• Whether any mechanism is available for Panel Lawyers to seek Case Specific Guidance?

- **Two tier** mechanism is available in the state of Jharkhand for panel lawyers to seek case specific guidance:
- **Firstly** on the last Sunday of every month **Orientation Programme** is organised at each DLSA in which Secretary, DLSA and other Judicial Officers participate with Panel Lawyers where formal and informal interaction with panel lawyers affords opportunity for general guidance as well as case specific guidance.
- **Secondly**, once in every two month in the meeting of district level monitoring committee, case specific or general guidance is given to panel lawyers.

Suggestion of JHALSA for enhancing quality of representation :

- **Nalsa has taken most befitting step to enhance the quality of Legal Services Panel Lawyers by imparting training of lawyering skill and for this purpose in each state trained trainers have been prepared. Now there is requirement of more TOTs and therefore a list of Resource Persons should be provided to SLSAs to hold such TOTs as per our need to prepare more Trained Trainers to fulfill the demands of various districts.**

- **Development of Legal Services Online Case Tracking & Data Grid System is the call of the hour for enhancing quality of legal representation because it will open the Legal Services Data in Public Domain.**
- **The concerned Legal Services Institution must invoke the provisions of Regulation 15 of NALSA (Free & Competent Legal Services) Regulation, 2010 for engaging suitable Sr. Advocate depending upon the nature of case to improve the quality of legal representation in Court annexed legal services.**

• **Whether any action has been taken to revise the lawyers' fees?**

- Lawyers Fees has been fairly revised in the year 2013. The chart is given below:

- **Whether it is ensured that all persons in custody who do not have their private counsel, are represented by Legal Services Lawyers at remand, bail etc.?**

➤ Yes, It is always ensured.

Three tier system is in place in Jharkhand:

Firstly, during the time of remand the retainer lawyers assist the arrested person before the Magistrate if he or she is not represented by his/her lawyer.

Secondly, the Jail Legal aid clinic ensures that no under trial prisoner who has not yet engaged his/her own choice lawyer remain unrepresented by competent legal services panel lawyer.

Thirdly, in every jail Para-Legal Volunteers from amongst inmates have been trained and deputed who work as bridge between the inmates' requirement of Legal Services and Jail Clinic.

This is the way in which it is ensured that all persons in custody who do not have their private counsel, are represented by Legal Services Lawyers at remand, bail etc.

Suggestion of JHALSA :

- **Legal Services Institution should keep details of each & every inmate as to status of their case, court in which case is pending and whether represented by choice Lawyer or Legal Services Lawyer or unrepresented by any Lawyer.**

Are training programme for panel lawyers being regularly conducted?

➤ Three panel lawyers have been trained by NALSA under ToT programme in **July 2015** at New Delhi and they are imparting Lawyering skills training to the Panel Lawyers in his/her own district as well as other districts and

- Similarly, training of Panel Lawyers in all the Districts is also imparted as per the Yearly programme chalked out by JHALSA and same is held on last Sunday of each month in each district.

- **Whether more ToTs are required and whether the same can be arranged within the State or region?**

Yes. More ToTs are urgently required. At present there are only 4 persons trained under ToTs namely; Navneet Kumar, Member Secretary, JHALSA, Ms. Kiran Tiwari, Advocate from Dumka District, Sri Prakash Ranjan, Advocate from Palamau District and Sri M.S Ganguly, Advocate from Ranchi District. Atleast at the rate of one master trainer in each district, 20 master trainers are required for state of Jharkhand and we are ready to conduct ToT Programme in our state or region (more than one state).

Suggestion of JHALSA :

- **There should be a NALSA Calendar for organizing TOT Programme for Panel Lawyer and it should be organized at State/Regional Level and the Resource Persons should provided by NALSA and the expenses shall be borne by Host State.**

Item No.4 Performance of Legal Services Clinics.

A. Care and Support Centres in Village/Community.

• Whether the frequency of operation of the clinic is sufficient?

- No, it is not sufficient. It should operate on all 7 days of the week. Presently the frequency of operation of legal services clinic is 16 days a month including all the Sundays and Wednesdays mandatorily in the State of Jharkhand.

Suggestion of JHALSA :

- **The requirement for Legal Services may arise anytime anywhere therefore Legal Services Clinics should work all seven days.**

• Whether activity registers are maintained and periodically verified?

- Activities Registers are thoroughly maintained.
- **Three tier** activity register monitoring mechanism is in place in State of Jharkhand:
Firstly the registers are verified by retainer lawyer and report is submitted to Secretary, DLSA.
Secondly, it is verified by the Secretary, DLSA and randomly cross checking is done by talking to the beneficiaries at this level.
Finally, the registers are verified at Chairman, DLSA level.

• Whether clinics are also engaged in identifying socio-legal issues in the particular area and conducting awareness / literacy programmes on the relevant subject matters.

- Jharkhand State Legal Services Authority has identified the socio legal issues for awareness in the State of Jharkhand and has included the same in its Activities Calendar and awareness programmes/ literacy programmes on relevant subject matter are organized in all the 24 districts across the state of Jharkhand.

B. Jail Clinics

• **Whether set up in all jails?**

- Yes, Jails Legal Services Clinics have been setup in all **25 Jails** in Jharkhand and same are functioning.
- The Jail Legal Services Clinic are manned by **52** Jail Legal Aid panel lawyers and **123** PLVs out of jail inmates.

• **Is their frequency of operation sufficient?**

- Yes, the frequency of operation is sufficient as under
- Jail inmates trained and enrolled as para legal volunteers provide legal services and advice on all the six week days.
- Panel Lawyers visit jail legal aid clinic two days a week for expert advice and legal services.

• **Whether Jail Clinics reach out to all under-trial prisoners and maintain records of their status with regard to engagement of counsel, bail, final results of the case etc.?**

- Yes, Jail clinics are able to reach out to each and every under trial prisoner and records of their status with regard to engagement of counsel, bail and final result of cases etc are duly maintained.
- Jail clinics reach out to all under trial prisoners through jail inmates trained and enrolled as PLVs, Panel Lawyers and Secretary, DLSA.

Modalities of duties to be assigned to the Jail Inmates enrolled as PLV

Pursuant to :

**Order dated 5th May, 2015 passed in W.P. (PIL) No. 2774 of 2013
By Division Bench of Hon'ble High Court of Jharkhand**

Duties

1. Since PLVs in jail are those prisoners who are serving long term sentences, therefore they know the legal services-needs of other inmates and he has to act as bridge between the Legal Services Institutions and the 'prisoners in need of legal aid/services.
2. They shall make the inmates aware about the aim and objectives of DLSA regarding free legal aid available to the inmates.
3. They shall inform the DLSA regarding the legal aid required to all the inmates with respect to appointment of lawyer from defence panel of DLSA.
4. They shall write applications on behalf of inmates for seeking legal aid from DLSA.
5. They shall enquire about the period of detention of inmates/under trial prisoners from the office of concerned Jail and also about the nature of offence and inform the DLSA regarding the under trial prisoners who may get benefit of provisions U/s. 436 A Cr. P.C.
6. They shall inform the DLSA regarding filing of appeal/revision on behalf of inmates
7. They shall inform the DLSA regarding the inmates who were enlarged on bail but are languishing in jail due to non-availability of bailers.
8. They shall constantly keep a watch on the transgressions of law or acts of injustice inside the jail and bring them immediately to the notice of DLSA for effective remedial actions.
9. When the new inmate comes inside the jail, it is the duty of PLVs to interact with him/her and get aware whether he/she has a lawyer or not and inform the same to the DLSA.
10. In case when any convict states about filing about appeal on his behalf before the Hon'ble Court, it is the duty of PLVs to get collected the number of appeal filed on his behalf and if no such number has been provided by such convict, they have to report the matter to the DLSA.

- Jails clinics are doing wonderful work in jails and on the particular day all the inmates are duly informed about the sitting of the panel lawyers on the legal aid clinics to take legal advice including engagement of counsel etc.

Suggestion of JHALSA :

- **Jail Clinics should be developed as DLSA’s extention counter considering the nature and scope of legal services required to be provided to jail inmates depending upon number of inmates.**

• How are the grievances handled?

- Under-trial Prisoner Grievance Redressal Mechanism as developed in the State of Jharkhand and followed here is as under:
 - a. Every Jail has Legal Aid Clinic duly run by DLSA and visited by DLSA Panel Lawyer. Under trial prisoners are approached by the Panel Lawyers in the Jail Premises as also in the Legal Aid Clinic of the Jail and Report is submitted to the Secretary, DLSA on the same date.
 - b. In every Jail there are PLVs from amongst the Jail inmates and the grievances of co-prisoners are intimated by these PLVs also to the concerned DLSA.
 - c. The Superintendent of Jails forward the application of under-trial prisoners to the Legal Services Institution (DLSA,/HCLSC/SLSA)
 - d. Jail Adalat is conducted once in every month and same is attended by the Judicial Officers and Secretary, DLSA and Legal Awareness is also conducted every month by the DLSA.

C. Clinics in Schools/Law Colleges/Universities.

• Whether setup in all Law Schools in the State?

- Yes at present there are 9 such clinics are operational in Law Colleges/Universities.
- Further there are 112 literacy clubs functioning in the schools of state of Jharkhand

JHALSA initiatives help unchain mentally-ill boy

A 16-year-old boy, who was leading a miserable life in the city since early childhood, was today admitted to Ranchi Institute of Neuro Psychiatry and Allied Sciences (RINPAS) for better treatment on the basis of Bhukhand Legal Services Authority (JHALSA). The boy, named Rahul, was kept chained by his parents as he used to run away from home due to mental illness in a village in Chhota Nagpur.

The initiative was taken by Justice DN Patel, Executive Chairman, JHALSA when he read a report of the child in a vernacular newspaper. JHALSA took cognizance of the matter and directions were issued by Justice Patel to submit a report with respect to the news report to DLSA, Chhota Nagpur.

The Principal District and Sessions Judge cum Chairman, JHALSA, Chhota Nagpur, in his report submitted that Secretary, DLSA, Chhota Nagpur, Child Welfare Committee, Chhota Nagpur and Civil Surgeon, Chhota Nagpur visited the house of the mentally ill child to verify the genuineness of the matter.

Secretary DLSA, Chhota Nagpur in his report submitted that Rahul Kumar is living with his mother in Mendra and other family members at his village with some family members.

The Secretary further said that when asked to free Rahul, he was told by his mother and family members that it is for his safety and security that he has been kept under strict supervision, either he will run away or keep himself confined holding the door from inside and will be in trouble of safety and security of his, since he is a mentally ill child.

The team of CWC, Chhota Nagpur also visited the house of Rahul and found the same as described before and observed that Rahul led a miserable life till the age of 16 years and thereafter was treated at Sakar Hospital, Chhota Nagpur for mental illness, but could not be cured and due to poverty, his guardians could not continue his treatment and presently he is not getting any medical treatment.

On examination, he was conscious but not oriented to time, place and person completely. He talks incoherently in the light of such findings, the medical team recommended Rahul for Neuro Psychiatric management at a higher centre.

After perusal of the report submitted by Chairman, DLSA, Chhota Nagpur, the Executive Chairman, JHALSA asked him to take immediate steps for better treatment of Rahul at RINPAS, Ranchi.

Accordingly DLSA, Chhota Nagpur took necessary steps for shifting of Rahul from Chhota Nagpur to RINPAS, Ranchi, Ranchi for his proper treatment. Free of cost work co-ordination at all the stakeholders of the State so that the ailing child may recover from his illness and may lead a normal life.

Vinay Kumar, Deputy Director, RINPAS, Ranchi, Dr. Prayans Kumar, India and Deputy Secretary, JHALSA, were present at RINPAS to ensure the proper care and arrangement for treatment of Rahul at RINPAS, Ranchi, Ranchi.

Quality & Responsive Legal Services to Women suffering from Naxal Violence

One Naxal Victim handicapped lady named LUGNI who can't even move on her leg and was abducted and raped by Naxals in the year 2011 and due to that she gave birth of her boy child. She made appeal through media for adoption of her 3-year old son, because she is unable to look after him.

Immediately State and District Legal Services Authority sprung into action and on their intervention the said tribal boy was put under Foster Care and quality education was ensured to him. And the District Administration has provided her all the benefits under Social Security Schemes.



• **Whether they can be utilized to conduct social and legal research?**

- The Senior students of the Universities can be utilised to conduct social and legal research, particularly on the condition of the victims of social evils like gender violence, ethnic violence, witch practice, child marriage, dowry, superstitions etc. and the kind of Legal Services & Govt. Beneficial Schemes that would ameliorate their sufferings.
- Apart from above the law students are being engaged in the legal awareness and sensitization programme conducted in jail by the DLSA for providing legal services to under trial prisoners.

Suggestion of JHALSA :

- **Legal Literacy Club should be opened in each and every school from middle school level so that young citizens may be made aware of and sensitized about the laws and socio-legal issues of the land.**
- **Legal Services Clinic should be opened in every Law College, Universities and Other reputed institutions for quality and responsive justice at door step.**
- **One Legal Aid Clinic may be established in chamber of commerce to deal with their disputes.**
- **One Legal Aid Clinics is urgently required to be established in the old age home to look after the pensionary needs as also other needs of senior citizens.**

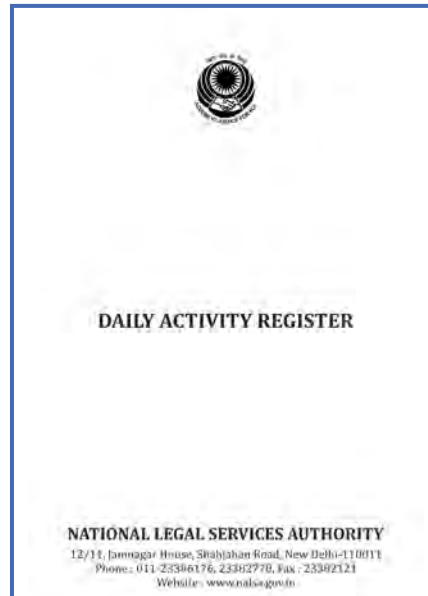
Item No.5 Need based Utilisation of Para-Legal Volunteers:

• Nature of activities carried out by PLVs.

- Firstly, Para Legal Volunteers in the state of Jharkhand carry out the duties as envisaged in NALSA Revised Scheme.
- Para Legal Volunteers in the state of Jharkhand are members in each of the 7 team constituted in each district of the State of Jharkhand for implementing the recently launched NALSA 7 schemes.
- Over and above the PLVs in the State of Jharkhand carry out following duties as well.
 1. *Organising Awareness Programme to make people aware of their right to get Legal assistance through the legal services institutions.*
 2. *Helping the family of child missing or child trafficking through the DLSA in recovery and rehabilitation of the child.*
 3. *Organising programme to make people aware of benefit of Mediation, Conciliation and Permanent Lok Adalat.*
 4. *Helping the victim of Crime to approach the DLSA for compensation under the Victim Compensation Scheme of the State of Jharkhand.*
 5. *Helping the people to get benefit of the Govt. beneficial schemes.*
 6. *Participating in the programmes of the DLSA.*
 7. *Referring people to the DLSA for Legal assistance.*

8. Participating in the capacity building Programmes organized by the Legal Services Institutions.
9. Visiting the Jail, Hospital, Observation Home, Probation Home, Govt. offices in connection with Legal Services Activities.
10. Resolving Family dispute or other dispute in the locality.
11. Maintaining record of daily activities.
12. Submitting record of activities to the DLSA every month.
13. Distributing publicity materials on Legal Services, govt. beneficial Schemes as well as Legal Literacy Literature published by NALSA and JHALSA on important Legislations
14. Reporting the DLSA about the violation of Child Rights, Communal harmony and Naxal Victims.
15. Making himself well aware in the locality and ensuring his easy access so that people may feel free to approach him for legal assistance.

Suggestion of JHALSA :

- Considering the nature and scope of PLVs work expanding day by day, they should be given one day remuneration (Rs. 400) as mobile charge for effectively connecting with common people.

• What kinds of specialised training if any is required for PLVs?

- A society is judged on the criteria as to how it treats its women, sr.citizens, differently-abled persons, inmates, weaker and marginalised sections of population/society etc. NALSA has recently launched **seven schemes** for weaker and marginalised sections of the society, therefore specialised training on those schemes is required for PLVs because PLVs are harbingers and main workforce of Legal Services Institutions at grass root level.

- To create well trained force of PLVs for each of the 7 schemes of NALSA, there should be calendar of SLSA for specialized training of PLVs related to topics mentioned in NALSA 7 Schemes. Such training should be organized at District Level as also at group of Districts & State Level.

4. NALSA (Legal Services to the Mentally Ill and Mentally Disabled Persons) Scheme, 2015,
5. NALSA (Effective Implementation of Poverty Alleviation Schemes) Scheme, 2015,
6. NALSA (Protection and Enforcement of Tribal Rights) Scheme, 2015,
7. NALSA (Legal Services to the Victims of Drug Abuse and Eradication of Drug Menace) Scheme, 2015

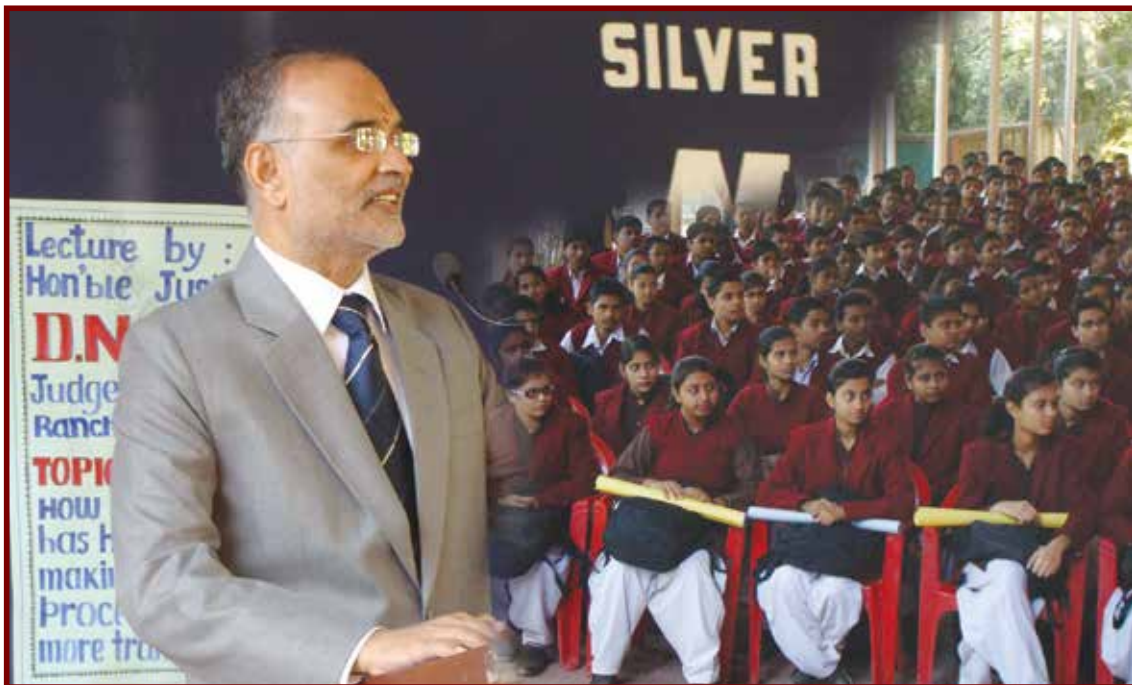

Suggestion of JHALSA :

- Just like a hospital consists of different wards, disease-wise, similarly Legal Services centres in jails clinics should also have different cells to look after the Legal Services needs of inmates like Magisterial Trial Inmates, Session Trial Inmates, Inmates whose matters/appeals are pending in High Court and inmates whose matters/appeals are pending in the Supreme Court and each cell should be manned by Panel Lawyers, Jail PLVs & one Judicial Officer should be incharge of the cell. There should one more cell in Jail Clinic to look after the other miscellaneous matters such as food, cloth and medical facility.

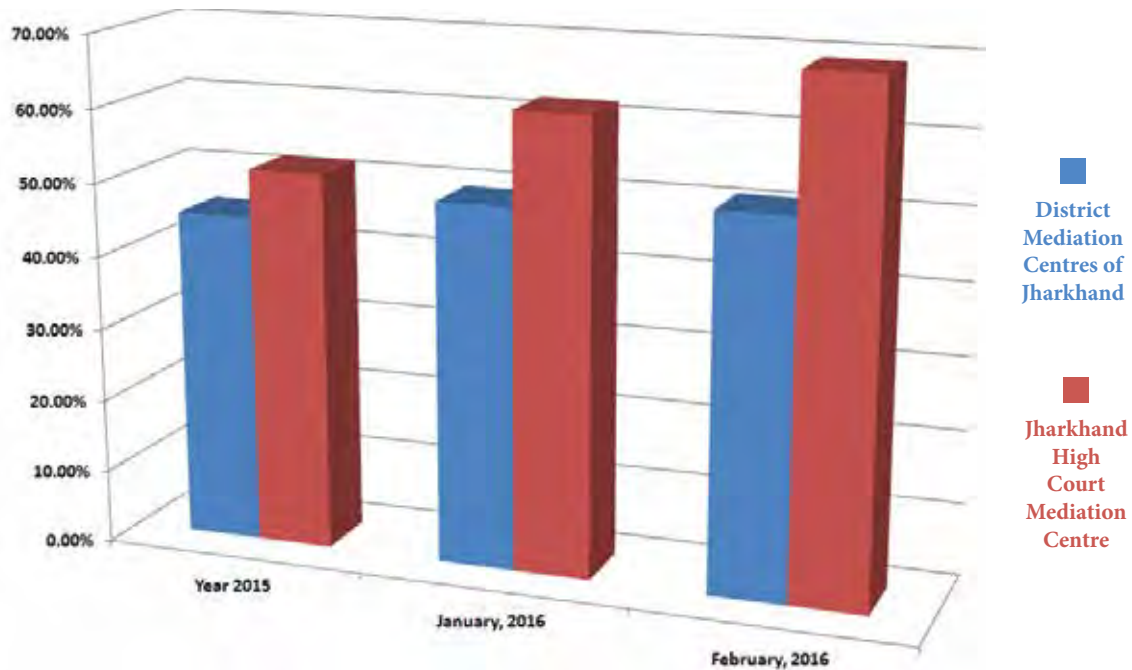

Suggestion of JHALSA :

- **Need based Continuous Lok Adalat under section 19 of Legal Services Authority Act 1987 is required to be constituted so that as and when the matter is referred under section 89 of CPC, the matter may be taken up in continuous Lok Adalat same day and parties may not have to wait till the appointed date of the month when the Lok Adalat is scheduled to be organised (For example Lok Adalat is organised on Last Saturday of the Month in Jharkhand)**
- **It is the need of the hour to have Lok Adalat Division, Mediation Division and Legal Aid Division in each DLSA so that in effective manner care and attention may be given to each of them.**
- **Serving Judicial Officer should be appointed as Chairman, PLA in view of (i) the increase of pecuniary limit upto Rs. 1 Crore and addition of 2 new subject matters namely : Real Estate & Educational Institutions and (ii) need for actualizing the services of PLA upto the level of District Court for the benefit of common people in public utility matters.**
- **Continuous Intensive Training of Referral Judges must be conducted on regular basis and for this purpose NALSA should prepare a panel of resource persons of national repute so that the SLSAs may invite them from time to time.**
- **Non-Advocate Mediators Like experts, retired senior bureaucrats, retired senior executives etc should be included in the panel of mediators as per the mandate of rule 5(c) of Mediation Rules 2015 so that their expertize may be utilized in complex or highly technical matters.**

Item No. 9 Victim Compensation Scheme under Section 357-A, Cr.P.C.

- **Whether the disposal of the fund under the Victim Compensation Scheme is with the Legal Services Institutions or with some other Authority in the State?**

➤ As per the Jharkhand Victim Compensation Scheme, 2012, the Victim Compensation Fund is operated and controlled by the Director, Prosecution, Govt. of Jharkhand.

- **Implementation of the Central Government Victim Compensation Scheme where the State is having its own Victim Compensation Scheme.**

➤ Central Victim Compensation Fund Scheme (effective from 21st August, 2015) has not been implemented in the State of Jharkhand and most of the other states because amount payable under the Jharkhand State Victim Compensation Scheme as also other States' Scheme is much below the Central Scheme and **the essential requirement to access funds from Central Victim Compensation Fund is that the quantum of compensation notified should not be less than the amount mentioned in annexure-1 to the Central Scheme.**

Note : If the victim is less than 14 years of age, the compensation shall be increased by 50% over the amount specified above.

- The objective of the Central Victim Compensation Fund Scheme was to reduce disparity in quantum of compensation amount notified by different states for Victims of similar crime but due to the lackadaisical approach of the Government Authorities the benefit of Central Scheme amount is not going to the victims of the offence in Jharkhand.
- Executive Chairman, JHALSA has impressed upon the Chief Secretary, State of Jharkhand vide His Lordship's letter to amend the Jharkhand Victim Compensation Scheme in tune with Central Victim Compensation Fund Guidelines.
- Jharkhand Victim Compensation Scheme 2012 provides for compensation as follows:

9.	Simple Loss or injury to Child victim	Rs. 10,000/-
10.	Acid Attack Victims	Rs. 3,00,000/-

9 Point Strategic Management

for Effective Implementation of Victim Compensation Schemes

- 1) Jharkhand State Legal Services Authority shall open a dedicated **One Stop Desk** at each DLSA/SDLSC of the State for rendering help to the Victims or their family members in the matter of getting the compensation.
- 2) JHALSA shall establish a dedicated pool of **panel lawyers** and **para-legal volunteers** for effective legal aid in the matter of compensation to the victims of the offences including the Naxal violence and acid attack victims.
- 3) **Legal Aid Clinics** at the Jails shall be instructed to render all kinds of help to victim of the offences or the successors of the victim of the offence in preparing application form in the proposed format for getting compensation under the Jharkhand Victim Welfare Fund Rules, 2014.
- 4) Extensive Legal Awareness activities shall be organized by the Legal Services Authorities across the State of Jharkhand for creating awareness regarding various schemes for compensation to victims of the offence. The Legal Awareness Programme "**Kanoon ki Baat**" on **Doordarshan** and **Radio** shall include the topic of compensation to victims of the offence including the Naxal and acid attack victims.
- 5) **Justice on Wheels** shall also be utilized for propagation of Victim Compensation Schemes through Mobile Vans.
- 6) **Training and Sensitisation Programme** shall be organized for, Deputy Commissioner, Superintendent of Police, Jail Superintendent, Chairman and Secretary, DLSA and Principal Probation Officers once in every six month and Advance Training Programme shall be organized in collaboration with the Home Department, Govt. of Jharkhand once in every year by JHALSA.
- 7) **Application for compensation** from Victim Welfare Fund in prescribed format shall be made available at all the legal services institutions across the state of Jharkhand including the Legal Aid Centres at village level by JHALSA.
- 8) **Periodical Report** shall be submitted to Jharkhand State Legal Services Authority by the DLSAs/SDLSCs in respect of progress made in implementation of Victim Compensation Schemes including the no. of beneficiaries and JHALS in turn, after analyzing the report shall take appropriate steps to make more productive.
- 9) **Retainer Lawyer and Para Legal Volunteer** shall be available during the working hour on every working day at the one Stop Desk to be established at each DLSA/SDLSC for effective legal aid and advice to the victims or family member of victims of offence.

Suggestion of JHALSA :

- There is huge disparity in the amount of compensation fixed by different States to the victims of offence and there is urgent need for fixing the compensation amount strictly in tune with Central Victim Compensation Fund Guidelines (effective from 21st August, 2015).
- There is urgent need of a Victim Compensation Cell in each Legal Services Institutions for effective co-ordination between district authority, Jail Authority, Director Prosecution and District Court.

• Whether the utilisation certificates in respect of full utilisation of grants are being issued regularly?

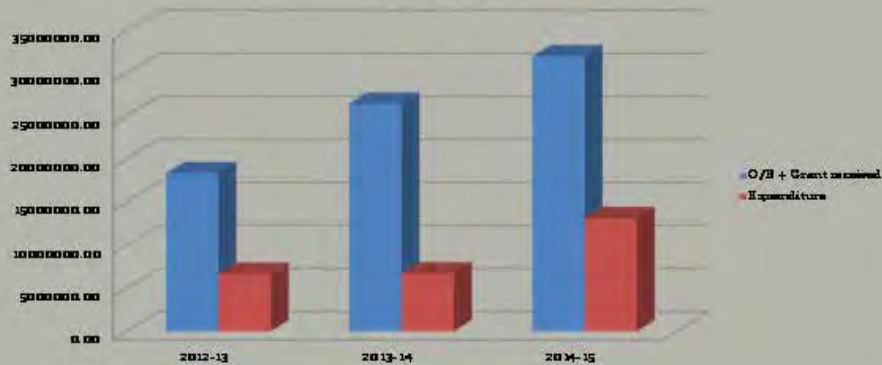

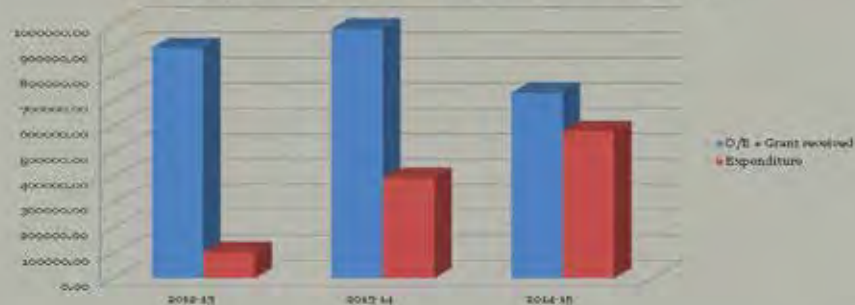
