You are humbly requested to prepare your schedule alongwith team of Judicial Officers (Sitting/Retd), (one legal Aid Panel Lawyer and one PLV for a single tour) for touring in different blocks of your concerned districts.

- The DLSA shall ensure that the Justice on Wheels is used optimally as far as practicable in the district during the tour of the Justice on Wheels. It shall be further ensured that after organizing Mobile Lok Adalat and Awareness camp at a particular village, haat, mela, bazaar etc the vehicle returns safely to headquarter the very same day.
- DLSA shall ensure proper propagation amongst the public where the Lok Adalat is scheduled to take place so that common villagers are ready in advance for disposal of their cases through the Lok Adalat at the spot.
- The DLSA shall liaison and coordinate with local administration so that petty offences and minor civil disputes can be resolved at spot in coordination with villagers as well as local body institutions.
- The DLSA while preplanning for Lok Adalat shall constitute Lok Adalat Bench in Mobile Lok Adalat as per NALSA Lok Adalat Regulation 2009.
- DLSA shall inform the media persons well in advance about the camps and Lok Adalats.
- DLSA shall utilize the District Legal Aid Fund(State Fund) in meeting the fuel expenses, maintenance, necessary repair work of mobile van as well as payment of daily wages to the driver @Rs.300/- and daily wages to the Khalasi @Rs.200/-, while for Panel Lawyer and PLV, NALSA fund may be utilized.
- DLSA shall ensure payment of wages to the Driver and Khalasi before parting with the vehicle for the next station.

After completion of the tour in your district a detailed report, together with newspaper clippings may be forwarded to JHALSA. The report should accompany the statistical data in the under mentioned format.
