The Court has been pleased to approve the schedule/ programme of the special drive of mediation of Family Court cases in the Family Courts/ District Courts of the State of Jharkhand for the four quarters of the calendar year, 2019 which is as under:-

Calendar Year	1 st Special Drive of Mediation (Quarterly period January to March, 2019)	2 nd Special Drive of Mediation (Quarterly period April to June, 2019)	3 rd Special Drive of Mediation (Quarterly period July to September, 2019)	4 th Special Drive of Mediation (Quarterly period October to December, 2019)
2019	March 11, 2019 to March 13, 2019	June 24, 2019 to June 26, 2019	September 23, 2019 to September 26, 2019	December 16, 2019 to December 18, 2019

In this regard, the Court further desires the following guidelines stipulated hereunder for the judgeships:

1. in addition to Family Court cases, connected cases filed for the offences punishable u/s 498A of IPC, custody of children, cases related to domestic violence be also referred to mediation for the special drive.
2. to submit a category-wise list of cases which shall be at least 10% of the total pendency before the respective courts for mediation in which Mediation can be made by trained mediators at the judgeship in the following format, at least 20 days before the scheduled date of special drive to this Court. The parties to such selected cases be directed to be present any day during the drive to be fixed by the court concerned.
