In exercise of the powers conferred in Section – 28 (1) and 28 (2) of the Legal Services Authority Act, 1987 the State Government, in Consultation with the High Court of Jharkhand, make the following amendment in Rule – 16 of the Jharkhand State Legal Services Authority Rules, 2001 :-

1. In the Rule-16, for the amount "Rs.1,00,000/-" amount "Rs.3,00,000/-" shall be substituted, and with this amendment, Rule – 16 would be read as :-

Rule - 16

"Persons eligible for legal services – Persons who are bonafide residents of Jharkhand having income of not more than Rs.3,00,000/- per annum under Section – 12 (h) of the Act shall be eligible for legal services under the Act."

2. This amendment shall come into force from the date of this notification.
