With reference to the letter above on the noted subject, as directed, this is to inform you that Hon'ble the Executive Chairman, JHALSA has been please to approve enhancement of ceiling limit regarding purchase of mobile set for the Officers of HCLSC, DLSAs/SDLSCs of Jharkhand in the light of Hon'ble High Court's office order No. 95/Accts. Dated 10.02.2020 (Ceiling limit at Sl. No. 2 is applicable for Secretary, HCLSC, sl. No. 5 is applicable for Secretary, DLSA & sl. No. 6 is applicable for Secretary, SDLSCs) (copy enclosed). Such purchase is to be made from Office Expense Fund and the life span is fixed to be 2 years after which new mobile handset may be purchased after returning the old mobile handset.
