In exercise of powers conferred under the provision of Section 22-B of the **Legal Services Authorities Act, 1987 (No.39 of 1987)**, the **Permanent Lok Adalat (Other Terms and Conditions of Appointment of Chairman and Other Persons) Rules, 2003** and **Law Department, Jharkhand Memo No.2094 dt 26-8-14**, the **Jharkhand State Legal Services Authority**, do hereby, appoint the following persons under Clause (b) of Sub-Section (2) of Section 22B of the Legal Services Authorities Act, 1987 (No.39 of 1987) as the Members(Other persons) of Permanent Lok Adalat of the respective districts for an initial period of **two years**.

Note:-

1. The candidates are requested to assume charge as Member (other person), Permanent Lok Adalat within 21 days from the date of notification and the tenure of initial period of two years shall be calculated from the day they assume charge as such.
