In exercise of powers conferred under the provision of Section 22 B of the Legal Services Authorities Act, 1987 (No.39 of 1987) and under the provisions of the Permanent Lok Adalat (Other Terms and Conditions of Appointment of Chairman and Other Persons) Rules, 2003, the Jharkhand State Legal Services Authority, do hereby, appoint the following persons under Clause (a) of Sub-Section (2) of Section 22B of the said Act as the Chairman of Permanent Lok Adalat of the respective districts for an initial period of two years.

Note:-

1. The candidates are requested to assume charge as Chairman, Permanent Lok Adalat within 21 days from the date of notification and the tenure of initial period of two years shall be calculated from the day they assume charge as such.
2. Before joining, the Chairman shall have to give an undertaking that he/she does not and will not have any such financial or other interest as is likely to affect prejudicially his functions as such Chairman.
