Sub.:- Hon'ble Patron-in-Chief's directives to DLSA, Deoghar, to the victims of stampede in Baba Dham Temple on the 2nd Monday of Shawan (10.08.2015)


Sir,

The Division Bench of Hon'ble Jharkhand High Court headed by Hon'ble Mr. Justice Virender Singh, Chief Justice, Jharkhand High Court and Patron-in-Chief, JHALSA sitting with Hon'ble Mr. Justice P.P. Bhatt, Judge, Jharkhand High Court, has been pleased to take suo-moto cognizance of the stampede arising in the wake of uncontrolled crowd in the Baba Dham Temple on 10.08.2015. The Hon'ble Court has been pleased to direct the undersigned by calling in person in the Court to take immediate steps by DLSA, Deoghar as under:

- To spring into action at once and open as many Legal Aid Clinics as is required for helping the victims of the stampede at various places.
- To immediately coordinate with the District Administration in relief works.
- To immediately open medical camp with the Doctors of Deoghar District Disaster Management Core Group of DLSA and ensure distribution of medicines in coordination with district administration.
- To immediately develop a Form for the victims of the stampede that may help them get the compensation declared/to be declared by union and/or State Government.
- To immediately constitute a Committee headed by the Secretary, DLSA to help the relatives of the victims as also the victims in the matter of getting the compensation amount and proper treatment.
- To immediately depute the Para Legal Volunteers for preparing documents for the victims or their relatives for getting compensation, for providing medicines to the victims, for informing the relatives of the victims etc.
- To prepare full detail of deceased, seriously injured and injured persons.
- To submit Interim Report within 48 hours as to the incident and the Action Taken Report.
- To use the DLSA fund for the expenses incurred in the relief work undertaken by the DLSA and for this cost fund of DLSA, Deoghar may be utilized.
