Successful Mediation can lay a ground work for collaborative, non confrontational problem solving and preserve relationships that are important to society and nation. With the panel of 187 energetic and experienced Advocate Mediators who were imparted extensive 40 hrs. of training by the Mediation and Conciliation Project Committee of Supreme Court of India in 16 batches, the caravan of Mediation is marching past one after another milestones successfully. With the advent of 17th Batch of Mediators (Experts, Retd. Senior Bureaucrats, Retd. Executives and Professionals) the movement of Mediation has sprung into mission mode in the State of Jharkhand. His Lordship Hon'ble Executive Chairman, JHALSA took note of the need to have a **Conclave on Mediation** in the State of Jharkhand to deliberate upon the present status of mediation as also the way forward. His Lordship viewed the **Conclave** to be beneficial for further cementing the faith of the litigants and common men and women in the Mediation. In ancient times also the people of our nation used to resolve their disputes through Panchayat where elders used to resolve their disputes through wisdom and counsel.

It is truly said that **Mediation is a cornerstone of the Justice Delivery System in our country**. Here in Mediation everything is okay in the end and if it is not okay then certainly it is not end. One such example is of a couple of Dhanbad, whose matter was pending at appellate stage in the High Court of Jharkhand and the couple were at litigating terms for 8 years and the matter was pending before the Division Bench presided by the Hon'ble Chief Justice, where this 8 years long dispute got resolved amicably and the warring couple got reunited. Therefore, certainly through mediation everything is okay at the end.

Hon'ble Mr. Justice Anil R. Dave, Judge, Supreme Court of India and Executive Chairman, NALSA appreciated the work done in the field of mediation in the State of Jharkhand. His Lordship encouraged the Mediators of the State of Jharkhand present over there to work hard. His Lordship shared the experience of His Lordship's earlier visit to the State and lauded the efforts made by the Patron-in-Chief and Executive Chairman, JHALSA.

His Lordship further said that the Mediation is a good thing and both parties are happy here and it settles relationship. His Lordship shared one experience where the dispute between brother and sister was resolved through mediation amicably.

- I am a trained mediator. It is my firm belief that mediation under most of the circumstances is best method of dispute resolution. It is best method of doing justice.
- His Lordship shared experience to establish **mediation is an art of finding solution no one can refuse.**
- His Lordship further shared experience to establish as to how **Mediation is Magic which unites hearts, relationship and human beings.**
- His Lordship further shared experience as to how it is **time and cost efficient method of dispute resolution.**



Hon'ble Mr. Justice Virender Singh, Chief Justice, High Court of Jharkhand-cum-Patron-in-Chief, JHALSA said in His Lordship address that :

- One of parametre to ascertain the success of Justice Delivery System is to know as to how quickly the matters are disposed of.
- Mediation plays very important role in disposal of cases.
- Let us understand the mediation from a different angle. When we talk of mediation we must try to know the root cause of problem, where is shoe pinching.
- Trained mediators have a knack of mediation and Mediation is required.
- So far as the success rate of mediation in the State of Jharkhand is concerned, as Patron-in-Chief, JHALSA, I am satisfied. The success rate is really satisfying.
- Through Mediation we have been able to dispose of many-many cases of commercial disputes & many other types of disputes.



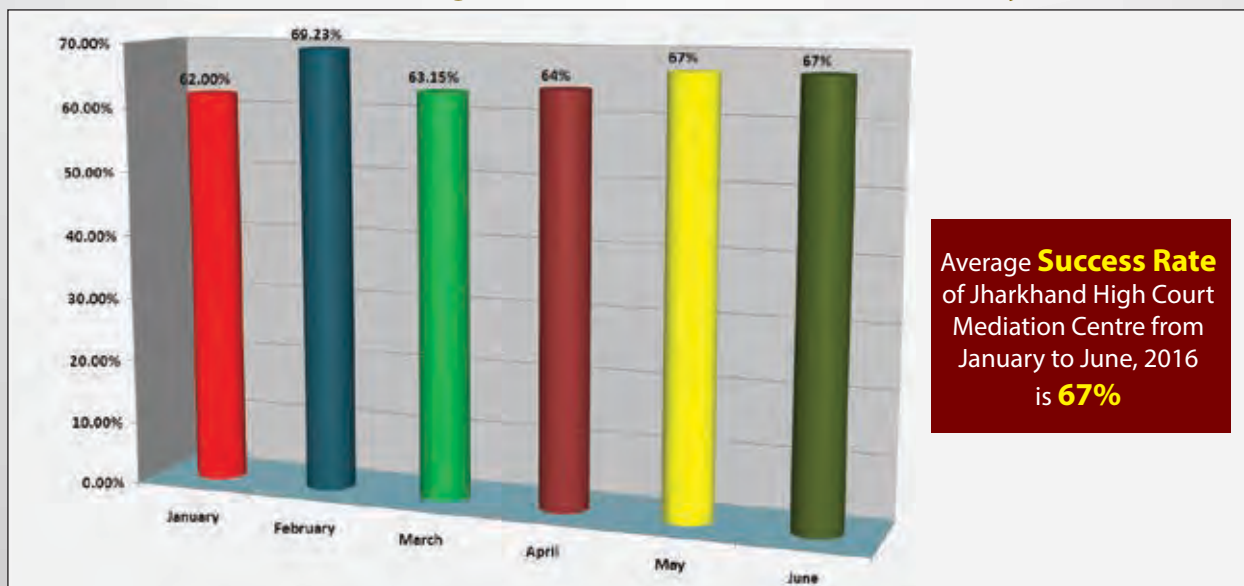

- As Executive Chairman, NALSA My Lord Justice Anil R. Dave has given a new meaning to Legal Aid in criminal matters by introducing the concept of Remand Advocate and His Lordship has approved the deputation of Remand Advocate in all Criminal Courts.

- Success rate of 17th Batch of Expert Mediators is 58% and that of overall state is 50%.

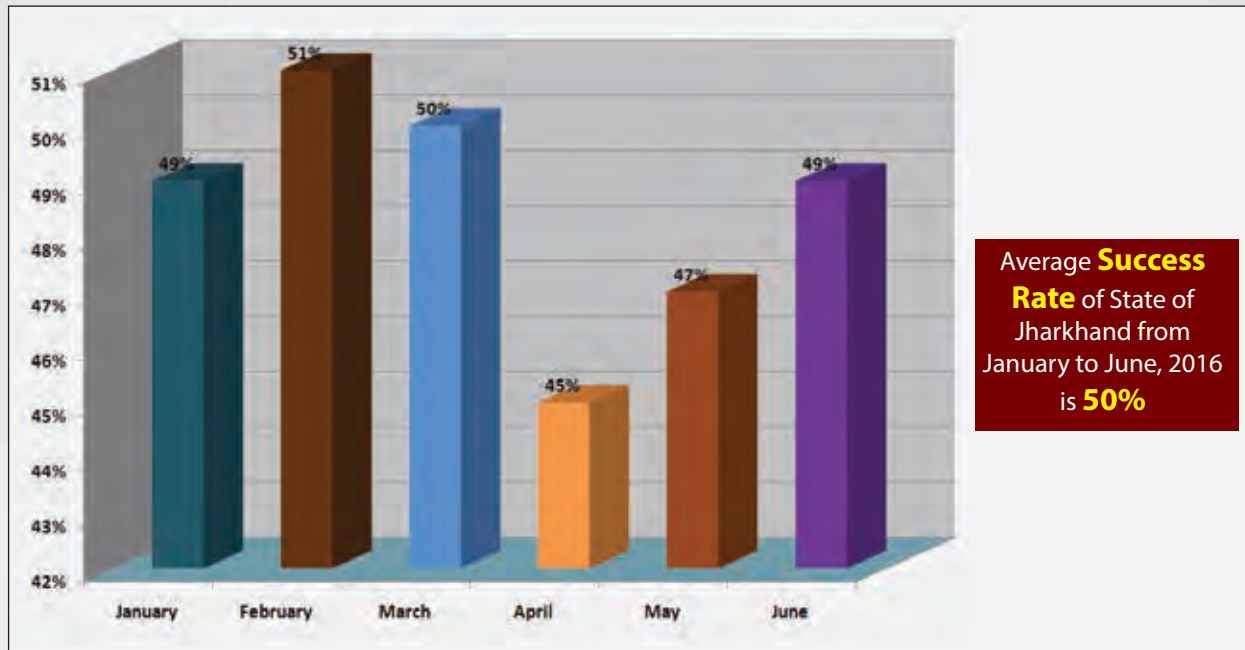

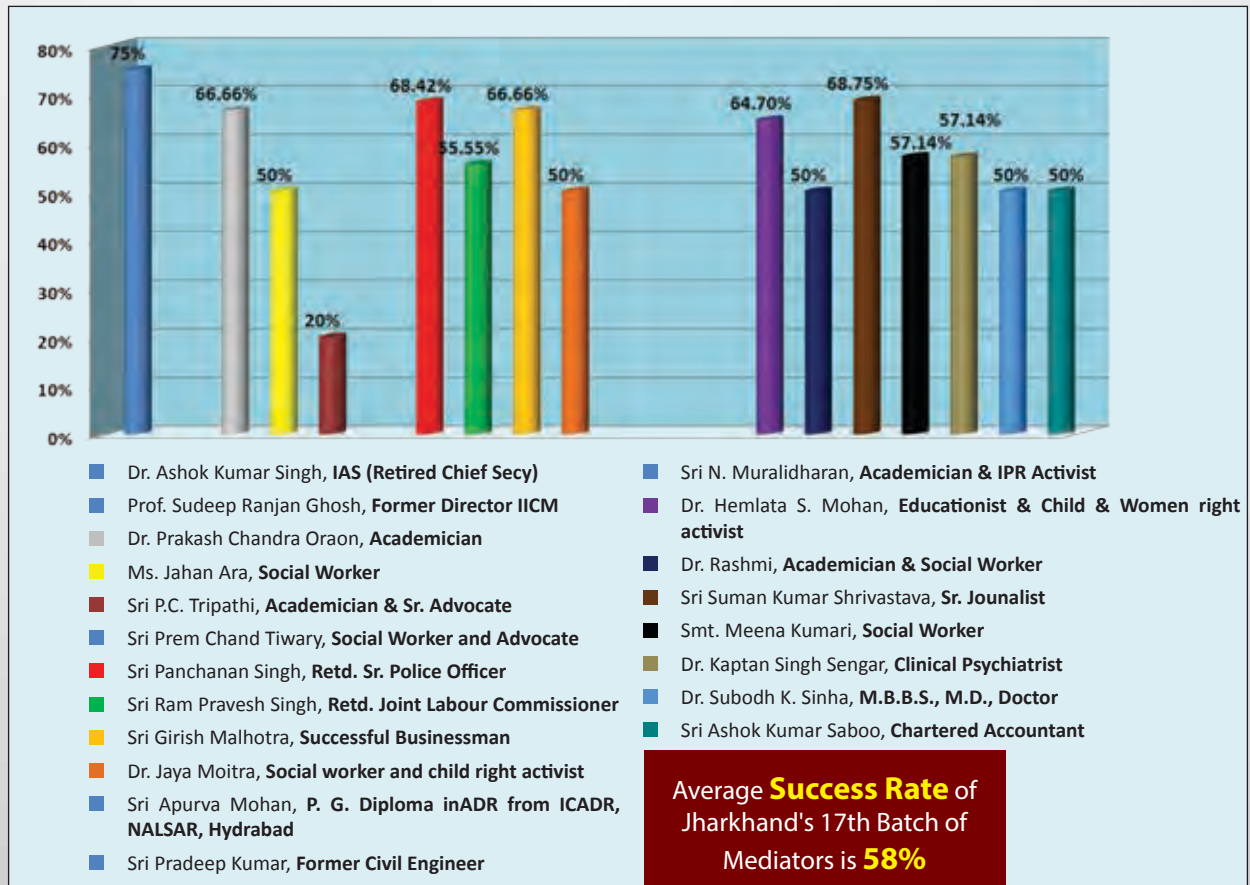
Success Rate of Jharkhand High Court Mediation Centre from January to June, 2016

SUCCESS STORIES OF MEDIATION IN HIGHLY COMMERCIAL MATTERS

Success Story - 1

Arbitration Appeal No.- 16 of 2012

State of Jharkhand and others. Vs. M/s Ravindra Mohan Tiwary

This highly commercial Matter was referred by the Hon'ble Mr. Justice D.N. Patel, Judge, High Court of Jharkhand to the High Court Mediation Centre, JHALSA, Ranchi vide order dt: 18/03/16. The mediation was conducted by chartered accountant mediator namely Sri. A. K. Saboo.

In the Mediation proceeding, the Chief Engineer, Water Resource Department, Hazaribagh and Superintending Engineer, Tenughat Dam, Tenughat were appointed as Nodal Officer.

Case in brief is that on 01/09/03, the Single Member, Arbitral Tribunal passed award. The Mediation was done on 09/05/16 and 16/05/16 and during Mediation both parties settled their dispute on the following terms and conditions:-

- 1) The Respondent agreed to take the Award amount along with 4% of interest in place of 12%. The total amount with interest in this way came to Rs. 7,99,704 which is to be paid within 1 month from 16th of May, 2016.
- 2) The aforesaid amount will be paid by way of Bank Draft or Account payee cheque.



Success Story - 2

Company Petition NO. 08/2015

M/s. Vikrant Forge Ltd., Kolkata vs. M/s Heavy Engineering Corporation Ltd., Ranchi

This highly commercial Matter was referred by the Hon'ble Mr. Justice D.N. Patel, Judge, High Court of Jharkhand vide order dt: 04/04/16 to Jharkhand High Court Mediation Centre for Mediation. The mediation was conducted by chartered accountant mediator namely Sri. A. K. Saboo. The Mediation proceeding commenced on 21/04/16 and on further dates on 3/5/16, 17/5/16, 11/6/16, 18/6/16, 4/7/16 and 16/7/16 and both parties amicably settled their dispute on following terms and conditions:

The parties agreed to settle for Rs. 21,22,794/- (Twenty One Lakhs Twenty Two Thousands and Seven Hundred Ninety Four) only in the manner specified in details herein below as full and final settlement as against the admitted outstanding dues amounting to Rs. 39,117621- (Thirty Nine Lakhs Eleven Thousands and Seven Hundred Sixty Two) only as on 30th June 2015 as claimed by the petitioner against the respondent in GP no. 08/2015

- Applicant M/s Vikrant Forge Ltd. received Rs.19,97,094/- (Nineteen lakh Ninety Seven Thousand and Ninety Four) only vide RTGS dated 12.05.2016 in the Account (No.20096218155) of Vikrant Forge Ltd and duly acknowledged by M/s Vikrant Forge Ltd.
- M/s Vikrant Forge Ltd. received a Cheque bearing No. 544136 dated 04.07.2016 of Rs. 57,600/- (Rupees Fifty Seven Thousand Six Hundred) only and Cheque bearing No. 544137 dated 04.07.2016 of Rs. 68,100/- (Sixty Eight thousand One Hundred) only as and final payment which applicant has duly acknowledged.
- M/s Vikrant Forge Ltd. undertook that no other payment on any account other than above will be claimed by them in future.
- In view of the above the M/s. Vikrant Forge Ltd. took a decision to withdraw the case and dispose it off as withdrawn without any direction on either Party.

This highly commercial matter was referred by the Hon'ble Mr. Justice D.N. Patel, Judge, High Court of Jharkhand vide order dt; 17/03/16 to Jharkhand High Court Mediation Center. The mediation was conducted by chartered accountant mediator namely Sri. A. K. Saboo. The Mediation proceeding commenced on 7/4/16 and on further dates 3/5/16, 17/5/16, 11/6/16, 18/6/16, 4/7/16 and 11/7/16, the mediation proceeding was conducted and on 11/7/16 both parties amicably settled their dispute on following terms and conditions :

1. The parties agreed to settle for Rs. 714.19 lakhs to be paid on or before 31/3/17 as full and final settlement against the outstanding dues or Rs. 9.28 crores.
2. The petitioner bank agreed to accept proposal of Rs. 714.19 lakhs towards full and final settlement in the manner as follows:
 - (i) Rs. 200 lacs on or before 30.06.16 (from sale of property described below);
 - (ii) Rs. 14.19 lacs on or before 31.07.16
 - (iii) Rs. 60 lacs on or before 31.08.16;
 - (iv) Rs. 250 lacs on or before 30.09.16 (final payment – from sale of property described below)
 - (v) Rs. 75 lacs on or before 30.11.16
 - (vi) Rs. 85 lacs on or before 28.02.17
 - (vii) Rs. 30 lacs on or before 31.03.17

Need more judges for speedy justice: CJI

Chief Justice of India (CJI) TS Thakur once again stressed on increasing the strength of judges in various courts in the country, saying it is a voice of people to ensure that justice in the minimum possible time and not for granting more leisure time to the judges. Chief Justice Thakur was addressing a gathering of mediators at Nyaaya Sadak here during a state-level convales on mediation.

"There are around 5 crore pending cases in the country out of which 2 crore cases are decided by the judges. Hence, I have seen scarcity of judges very closely and have also made honest efforts for increasing their strength," said the

back, while pointing out how the judges' dismal strength was hampering the justice delivery system.

Praising the efforts made by Jharkhand Legal Services Authority (JHALSA) in disposing of the cases through mediation, Justice Thakur further added that as many as two crore cases are decided in the Courts while 15 crore cases are disposed of successfully by these mediation centers. He also appealed to the mediators to involve themselves wholeheartedly in their job.

"It is like a movement... you should get associated with it like a judge as it is beneficial and meaningful as well," added Justice Thakur. Admitting the efforts made by the state government to

promote the development of institutions in Jharkhand, the Chief Justice of India also added, "Those governments which are always ready to invest in institutions are supposed to be better governments and I am glad to see that the same is being done in Jharkhand also," he said.

Supreme Court Judge Justice AR Datta also praised the works being done by JHALSA and said that the mediators by disposing of the cases, 'out' of Court are in a way helping the judges which is really commendable. "Mediation is a good thing, here there is no appeal and both the partners go home happily," said Justice Datta.

Calling mediation as the best form of Justice, SC Judge

Justice AK Sikri said that mediation in most of the circumstances is the best way of resolving issues. "We, even as a Judge, do not achieve things which in various times are achieved through it, as mediation is, most of the circumstances, is the best method of resolving issues," he said.

Expressing satisfaction over the success rate of JHALSA in disposing of cases through mediation, Chief Justice of Jharkhand High Court Vinayagar Singh, on the other hand, said that mediation now has become a tool of law and a part of Alternate Dispute Resolution System.

"Under the Chief Justice of India, we have taken a pledge that we will dispose of all the cases which have gone older than 3 years and we are working hard on that," said the Chief Justice of Jharkhand

High Court. Jharkhand High Court Judge cum Executive Chairman of JHALSA Justice DN Patel expected that they will be able to cross the mark of 50 per cent success rate in mediation in Jharkhand very soon in the coming years.

Later, the Judges of Supreme Court and Jharkhand High Court felicitated the mediators who did commendable job in these districts. This list includes the names of Surjan Kumar Subastav from Ranchi, Naitan Anan from Lohardaga, Roma De from Godda, Lakumohit Shukla from Pakur, Anil Verma from Khunti, Anil Chaudhary from Dugga and Barabhai Das from Jambhupur. The dignitaries also released a book 'Nyaaya Sadak' along with some other booklets.
