In exercise of powers conferred under the provision of Section 22-B of the Legal Services Authorities Act, 1987 (No.39 of 1987), the Permanent Lok Adalat (Other Terms and Conditions of Appointment of Chairman and Other Persons) Rules, 2003, the Permanent Lok Adalat (Other terms and conditions of Appointment of Chairman and Other Persons) Amendment Rules, 2016 and in light of Law Department, Jharkhand letter No.1912/J dt 20.8.2024, the Jharkhand State Legal Services Authority, do hereby, appoint the following persons under Section 22B (2) (b) of the Legal Services Authorities Act, 1987, as the Member (Other person) of Permanent Lok Adalat of the respective district for a term of 5 years or till the age of 65 years, whichever is earlier.


