Organized in the State of Jharkhand Under the aegis of **National Legal Services Authority** on 23rd November, 2013



The view of His Lordship Hon'ble Mr. Justice G.S. Singhvi, the then Judge, Supreme Court of India and Executive Chairman, National Legal Services Authority as regards Lok Adalats came to reality when a "National Lok Adalat" was organized on 23rd November, 2013 in the entire country as per the directives of NALSA. It was the result of active participation and concrete efforts of Hon'ble Mr. Justice D. N. Patel, the then Acting Chief Justice, High Court of Jharkhand & Executive

Chairman, JHALSA and the Zonal Judges of different districts of Jharkhand that the National Lok

Adalat became a resounding success. The settlement and disposal of large number of cases in the said National Lok Adalat had certainly rekindled the faith of the public in the judiciary and reassured them that the judiciary is concerned to their right to speedy and effective justice. On the said Oaccasion a Lok Adalat was also been organized by High Court Legal Services Committee, Ranchi in the premises of High Court of Jharkhand, Ranchi.

The said National Lok Adalt at Jharkhand High Court was inaugurated by Hon'ble Mrs. Justice R.Banumathi, Chief Justice, High Court of Jharkhand - cum - Patron-in-Chief by lighting of lamp in the benign presence of Hon'ble Mr. Justice D. N. Patel, Judge Jharkhand High Court & Executive, Chairman, JHALSA and Hon'ble Mr. Justice N. N. Tiwari, Judge, High Court of Jharkhand & Chairman, HCLSC, Ranchi. The said National Lok Adalat was also attended by Judicial Officers, Advocates, Officers of Local Government Administration, Students of DPS, Ranchi and a large number of common people and litigants.

Kalawati Devi lost her husband Giridhari Lal in the year 2004 in road traffic accident and since then she was awaiting compensation and the National Lok Adalat amicably settled the dispute and on the date of National Lok Adalat i.e. on 23.11.2013 cheque of Rs.3,29,175/was handed over to her.

Savitri Devi lost her husband

Jitu Gosi in road traffic accident on 25.07.2011 at 6.30 P.M at Baraghaghra, Namkum road and the wait for compensation amount came to an end in National Lok Adalat and on 23.11.2013 cheque of Rs.3,30,000/- was handed over to her on same day.



Success Story of DLSA Jamshedpur

Matrimonial Suit No. 314/2010

-versus-

Rina Devi wife of Ram Bhagat Singh daughter of Rajendra Singh @ Gopal Singh resident of Flat No. 183, Tube Colony, Baridih and Others Respondent.



The suit was filed by the applicant u/s 13(1)(a) of Hindu Marriage Act, 1955 for the decree of divorce. This suit was filed on 10-7-2010 and was admitted on 31-8-2010. The marriage of both the parties was solemnized on 5-5-2004 and the petitioner and respondent both resided in Jamshedpur and out of their wedlock two children were born. Thereafter this instant suit was filed on the various grounds but during the pendency of suit both the parties appeared before the National Lok Adalat and with the intervention both of them have settled their dispute before the National Lok Adalat and now they are living peacefully as husband and wife and their conjugal relationship has been restored.


