
Therefore, as directed, your goodself is requested to :

- involve the consenting Panel Lawyers/Remand Advocates/ Retainer Lawyers in the door to door campaign
- involve Judicial Officers in the campaign on holidays as head of the team of PLVs
- make payment of one day of Honorarium to the PLV for each day of campaign conducted by her/him
- make arrangement for security, brief halt/rest etc for the team in coordination with the district administration and police administration
- flag off the door to door campaign of your district on 9-11-2017
- take effective action on the legal aid request applications received by the PLV during campaign
- to effectively monitor the campaign on daily basis
