
Sir/ Madam,

Undersigned may kindly apprise your goodself that the Hon'ble Court has been pleased to inform that for making the provisions of Pre-Institution Mediation and Settlement of the amended Act, the Central Government in consultation with the National Legal Services Authorities, has notified the Commercial Courts (Pre-Institution Mediation and Settlement) Rules, 2018 on 3<sup>rd</sup> July, 2018 (Copy enclosed as Annexure-I) and also issued necessary notification to authorize the District and State Authority constituted under the Legal Services Authorities Act, 1987, for the purpose of Pre-Institution Mediation and Settlement, under the Act on 3<sup>rd</sup> July, 2018 in the Gazette Notification (Copy enclosed as Annexure-III).
