In exercise of powers conferred under the provision of Section 22-B of the Legal Services Authorities Act, 1987 (No.39 of 1987), the Permanent Lok Adalat (Other Terms and Conditions of Appointment of Chairman and Other Persons) Rules, 2003 and in consonance with Permanent Lok Adalat (Other terms and conditions of Appointment of Chairman and other Persons) Amendment Rules, 2016, the Jharkhand State Legal Services Authority, do hereby, appoint the following person as the Chairman of Permanent Lok Adalat of the respective district, for an **initial period of two years**.

Note:-

1. The candidate is requested to assume charge as Chairman, Permanent Lok Adalat within 21 days from the date of notification and the tenure of initial period of two years shall be calculated from the day he assume charge as such.
2. Before joining, the Chairman shall have to give an undertaking that he/she does not and will not have any such financial or other interest as is likely to affect prejudicially his functions as such Chairman.
