Entries received after the stipulated time shall not be entertained and shall be returned unopened.
- All the entries received by the stipulated date and time and found in order, shall be evaluated and the final selection will be made by the Hon'ble Executive Chairman, National Legal Services Authority, whose decision shall be the final.
- The Designers of the finally selected design and name will be awarded prizes as decided by the competent Authority of NALSA and the copyright of the selected design and name will vest with the National Legal Services Authority, upon such selection.
