In exercise of powers conferred under the provision of Section 22-B of the Legal Services Authorities Act, 1987 (No.39 of 1987), the Permanent Lok Adalat (Other Terms and Conditions of Appointment of Chairman and Other Persons) Rules, 2003, Law Department, Jharkhand letter No.1367/J dt. 22-9-2021 and in consonance with Permanent Lok Adalat (Other terms and conditions of Appointment of Chairman and other Persons) Amendment Rules, 2016, the Jharkhand State Legal Services Authority, do hereby, appoint the following persons under Section 22B (2) (b) of the Legal Services Authorities Act, 1987, as the Member (Other person) of Permanent Lok Adalat of the respective district for a term of 5 years or till the age of 65 years, whichever is earlier.


Note:-


