In exercise of powers conferred under the provision of Section 22-B of the Legal Services Authorities Act, 1987 (No.39 of 1987), the Permanent Lok Adalat (Other Terms and Conditions of Appointment of Chairman and Other Persons) Rules, 2003 and Law Department, Jharkhand Memo No.2841 dt 19-11-13, the Jharkhand State Legal Services Authority, do hereby, appoint the following persons under Clause (b) of Sub-Section (2) of Section 22-B of the Legal Services Authorities Act, 1987 (No.39 of 1987) as the Members (Other persons) of Permanent Lok Adalat of the respective districts for an initial period of **two years**.

Note:-

1. The candidates are requested to assume charge as Members (Other persons), Permanent Lok Adalat within 21 days from the date of notification and the tenure of initial period of two years shall be calculated from the day they assume charge as such.


